## EXHIBITOR GUIDELINES

1. Exhibitors are permitted by invitation only.
2. Applications are received and reviewed by the committee.
3. All exhibited crafts should be handmade by the exhibitor.
4. The fee is \$50 for space with electricity and \$35 for space without electricity.
5. Exhibitor space includes 1 8 ft table and 2 chairs.
6. Exhibits are not to exceed the allotted exhibitor space.
7. Exhibitors are required to be present in order to sell their own merchandise.
8. All exhibitors are required to be set up by 8:30 A.M. and remain until 2:00 P.M.
9. Each exhibitor will be allowed to bring only two categories of items.
10. Exhibitors are not permitted to share booths with another exhibitor or to sell any other person's merchandise out of your booth.
11. All exhibitors must exhibit only items submitted on the application. Additional items must be approved by the JMMF Sip, Shop, and Social Committee.
12. If accepted, you will be issued an invitation.
13. Refunds for cancellations will NOT be provided.
14. Exhibitors are only allowed one (1) booth during Sip, Shop, and Social.
15. Original items are strongly encouraged by the exhibitor and must be in finished form on event day.
